NEW ZEALAND CRAFTSMAN TRAINING FOUNDATION (INC)

The New Zealand Craftsman Training Foundation assists young people just starting out in their trade careers to gain industry skills and experience overseas without leaving their jobs in New Zealand.

The NZCTF places Awardees into short term roles (4-8 weeks) in top level international companies where they gain further training and practical work experience to bring back to their NZ employer.

Employees come home equipped with the latest overseas knowledge in technical skills and methods and feed their knowledge and skills back into the New Zealand industry, thus raising their own value and further identifying the skilled trades as a worthy and rewarding vocation. The NZCTF works in partnership with their Sponsors to provide travel scholarships for young tradesperson's who have recently completed their trade training, apprenticeship or recognised trade qualification to National Level 4 Standard, and who have been recognised by their employer/industry for future leadership potential.

WHY BECOME A SPONSOR?

Many Awardee Applicants are put forward by their Employer because the Employer views them as worthy of investing in for the future benefit of their business. Becoming a Sponsor creates a partnership between the NZCTF and the Employer, and we work together to build an experience for the employee that will be satisfying and rewarding for all parties.

NZCTF is a charitable organisation which means sponsors are able to benefit significantly from the recently changed tax laws. Sponsors are now able to claim back 1/3 of the cost of their sponsorship donation, up to the amount of their income. This is a significant financial benefit for organisations/persons donating to registered charitable organisations.

An additional benefit to sponsors is that they will be listed on our 'Sponsorship' webpage and invited to provide a link back to their company website. This acknowledgement recognises the sponsorship will help to give them exposure on our website.
